Clause iii) a) Probationary Rowing Member, 'Any person who is over the age of 11 years and up to 30 years."

"RESOLVED THAT pursuant to provisions of section 14 and other applicable sections of the Companies Act, 2013 read with the Companies (Incorporation) Rules, 2014 and other applicable provisions made there under (including any statutory modification(s) or re-enactment thereof for the time being in-force), the consent of the members of the Club be and is hereby accorded for substituting the following Clause iii (a) of the Articles of Association:

Clause iii) a) Probationary Rowing Member, 'Any person may be inducted as Probationary Rowing Member after obtaining approval from the Governing Body through the Membership Committee'."

Clause iii) b) Regular Rowing Member, Within one month of such approval, Rowing Committee shall put up a request to the Governing Body (through Membership Committee). Conversion is subject to approval by Governing Body."

Clause iii) c) Senior Rowing Member, 'A Regular Rowing Member may opt for Senior Rowing Membership on fulfilling specified criteria of the Club to be entitled to limited benefits of the Club on payment of a subscription. The Rowing Committee, after examining the pre-requisites will recommend his / her application to Governing Body (through the Membership Committee) for approval. Conversion is subject to approval by Governing Body.

"RESOLVED THAT pursuant to provisions of section 14 and other applicable sections of the Companies Act, 2013 read with the Companies (Incorporation) Rules, 2014 and other applicable provisions made there under (including any statutory modification(s) or re-enactment thereof for the time being in-force), the consent of the members of the Club be and is hereby accorded for substituting the following Clause vi (12) of the Articles of Association:

Clause vi (12) Election and Admission of Members, 'The spouse/family/next offspring of the deceased member must intimate the Club within 24 (twenty-four) months of demise, and within 2 (two) months thereof, the Club shall invite the deceased's ordinary member's spouse and such application for membership has to be made within 6 months of such invitation, and such membership shall be considered by the Governing Body only on payment of all arrears."

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

NOTES:

- 1. Pursuant to the circulars of Ministry of Corporate Affairs (MCA), it is permitted to hold the Extra Ordinary General Meeting (EoGM/the meeting) through VC/OAVM, without the physical presence of members at a common venue. In compliance with the provisions of the Companies Act, 2013 and MCA circulars, the EoGM of the Club is being held through VC/OAVM on Thursday, 23rd day of June, 2022 at 5:00 P.M. Hence, the Members can attend and participate in the ensuing EoGM through VC/OAVM. The deemed venue for the EGM will be the Registered Office of the Club.
- 2. Since this EoGM is being held pursuant to the MCA circulars through VC/OAVM, the requirement of physical attendance of members has been dispensed with. Accordingly, in terms of the MCA circulars, the facility for appointment of proxies by the members will not be available for this EoGM and hence proxy form, attendance slip and route map of EoGM are not annexed to this notice.
- 3. Members attending the meeting through VC/OAVM facility shall be counted for the purpose of reckoning the quorum under section 103 of the Act.
- 4. The word 'Company' and 'Club' are used interchangeably.
- 5. The expression 'Governing Body' means Board of Directors or Directors of the Company.
- 6. Words importing the masculine gender include the feminine.
- 7. Members may also note that the Notice of the EoGM will also be available on the Club's website http://www.bengalrowingclub.comfor reference and consideration.
- 8. Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) read with Circulars issued by the Ministry of Corporate Affairsin continuation to the Ministry's General Circular No. 14/2020 dated 08.04.2020, General Circular No. 17/2020 dated 13.04.2020, General Circular No. 22/2020 dated 15.06.2020, General Circular No. 33/2020 dated 28.09.2020, General Circular No. 39/2020 dated 31.12.2020, General Circular No. 10/2021 dated 23.06.2021, and General Circular No. 20/2021 dated 08.12.2021, it has been decided to allow companies to conduct their EGMs through Video Conference (VC) or Other Audio Visual Means (OAVM) or transact items through postal ballot in accordance with framework provided in the aforesaid Circulars up to 31st December, 2022.

The Company is providing remote e-Voting facility to its Members in respect of the business to be transacted at the EoGM and facility for those Members participating in the EoGM to cast vote through e-Voting system during the EoGM. The facility of casting votes by a member using remote e-voting system as well as e-voting on the date of the EoGM will be provided by NSDL.

NOTE FOR REMOTE E-VOTING:

1. The Club requests members who have not yet registered their email ID with the Club to do so at the earliest.

- 2. As per Article 36(c) of the Articles of Association of the Club, no member shall be entitled to vote at any general meeting unless all sums presently payable by him to the Company has been paid.
- 3. Members may join the EoGM through VC/OAVM facility by following the procedure as mentioned below which shall be kept open for the Members from 04:30 P.M. IST i.e. 30 minutes before the time scheduled to start the EoGM.
- 4. Members may note that the VC/OAVM Facility shall allow participation of 1000 Members on a first-come-first-served basis.
- 5. In compliance with Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules 2014, the Club is pleased to provide Members with the facility to cast their votes through remote e-voting which shall be available to Members from 20th June 2022 (Monday, 09:00 A.M.) to 22nd June 2022 (Wednesday, 05:00 P.M.). The remote e-voting module shall be disabled by NSDL for voting thereafter. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.
- 6. Members who avail the remote e-voting facility will not be able to vote during the EoGM through e-voting process.
- 7. Members may note the following instructions for casting their votes by e-voting system:
 - A. In case a Member wants to cast vote:
 - (i) Launch internet browser by typing the following URL: https://www.evoting.nsdl.com;
 - (ii) Click on 'Shareholder- Login' button;
 - (iii) Enter e-voting credentials (User Id and password) along with a verification code as shown on the screen. Your User ID details will be the EVEN Number followed by Membership Number registered with the Club (For example if Membership Number is A001 and EVEN is ****** then user ID is ******A001).
 - (iv) Your password details are given below:
 - If you are already registered for e-Voting, then you can use your existing password to log in and cast your vote.
 - If you are using the NSDL e-Voting system for the first time, you will need to retrieve the initial password which was communicated to you. Once you retrieve your initial password, you need to enter the initial password and the system will force you to change your password.
 - (v) If you are unable to retrieve or have not received the Initial password or have forgotten your password:
 - Click on Physical User Reset Password? Option available on www.evoting.nsdl.com.
 - Members can also use the OTP (One Time Password) based login for casting the votes on the e-Voting system of NSDL. OTPs will be sent to their registered Mobile Number. In case there is some trouble in receiving the OTPs, you may e-mail at evoting@nsdl.commentioning your name, membership number, and Club's Name.

- (vi) Home page of e-voting system opens. Click on e-voting: 'Active Voting Cycles';
- (vii) Select 'EVEN' of 'The Bengal Rowing Club';
- (viii) Now you are ready for e-voting as 'Cast Vote' page opens;
- (ix) Cast your vote by selecting appropriate option and click on 'Submit' and also 'Confirm' when prompted;
- (x) Upon confirmation, the message 'Vote cast successfully' will be displayed;
- (xi) Once you have voted on a Resolution, you will not be allowed to modify your vote.
- (xii) Members who do not have the User ID and Password for e-Voting or have forgotten the User ID and Password may retrieve the same by following the remote e-Voting instructions mentioned in the notice to avoid last minute rush. Further members can also use the OTP based login for logging into the e-Voting system of NSDL.

- 8. During the EoGM, the Chairman shall, after response to the questions raised by the members in advance or as a speaker at the EoGM, formally propose to the Members participating through VC/OAVM facility to vote on the resolutions as set out in the Notice of the EoGM and announce the start of the casting of vote through the e-Voting system. After the Members participating through VC/OAVM Facility, eligible and interested to cast votes, have cast the votes, the e-Voting will be closed with the formal announcement of closure of the EoGM.
- 9. Ms.Mamta Binani, Advocate, has been appointed by the Governing Body of the Club as the Scrutiniser, to scrutinise the voting process in a fair and transparent manner.
- 10. The Scrutinizer shall after the conclusion of voting at the EOGM, will first download the votes cast at the meeting and thereafter unblock the votes cast through remote e-voting and shall make a consolidated scrutinizer's report of the total votes cast in favour or against, if any, and whether the resolution has been carried or not, and such Report shall then be sent to the Chairman or a person authorized by him, within 48 (forty eight) hours from the conclusion of the EoGM, who shall then countersign and declare the result of the voting forthwith.
- 11. Only those Members/ shareholders, who will be present in the EoGM through VC/OAVM facility and have not cast their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system in the EoGM. Members who have voted through Remote e-Voting will be eligible to attend the EoGM. However, they will not be eligible to vote at the EoGM.
- 12. The results of the voting along with the report of the scrutinizer shall be placed on the Club's website www.bengalrowingclub.com. The results shall also be made available on the Notice Board of the Club.
